STATUTE CCCLXXIX/*REACTH CCCLXXIX*

WE, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University./*Faoi agus de bhua na gcumhacht sin a bheirtear dúinn ag na hAchtanna thuasluaite, déanaimidne, Údarás na hOllscoile ag Ollscoil na hÉireann, Gaillimh, tríd an ionstraim seo faoi Shéala Ollscoil na hÉireann, Gaillimh, an Reacht atá sa Sceideal seo thíos chun rialú ginearálta na hOllscoile sin.*

Schedule – STATUTE CCCLXXIX/*Sceideal* – REACTH CCCLXXIX

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth./*Déanfar Reachtanna uile Ollscoil na hÉireann, Gaillimh, roimhe seo a léamh agus a fhorléiriú maille leis na hathruithe, na breisithe agus na modhnuithe atá leagtha amach ina dhiaidh seo thíos.*

CHAPTER I

DEPUTY-PRESIDENT AND THE REGISTRAR

1. The Deputy-President and Registrar, acting under the general direction of the President, shall be shall be Chief Academic Officer; and shall be responsible for leading the academic leadership and strategy of the University; and shall do all such other acts and perform all such other duties in relation to the academic business of the University as she/he may be required by the President and by Údarás na hOllscoile to do or perform.
2. The Deputy-President and Registrar shall rank immediately after the President. The Deputy-President and Registrar shall assist the President and act as deputy to the President in such manner as the President shall direct.
3. The Deputy-President and Registrar shall be a full-time post and shall be a member of the University Management Team.
4. The Deputy-President and Registrar be appointed by Údarás na hOllscoile in accordance with the report of an Assessment Board appointed for the purpose by Údarás na hOllscoile, following recommendations as to its membership from the Academic Council. The Assessment Board shall carry out such interviews and other procedures as shall be determined by Údarás na hOllscoile, following recommendations as to the requirements of the role from the Academic Council, and which, in the opinion of Údarás na hOllscoile, will best ensure participation in the selection process by high-quality candidates from both within and outside of the University.
5. The Deputy-President and Registrar shall, subject to good conduct, a satisfactory one year probationary period, and due fulfilment of duties throughout the period of office, hold said office for a period of up to five years or until he/she shall have obtained the mandatory public sector retirement age, whichever period shall first expire, each subject to the terms set out in the employment contract and job description.
6. The Deputy-President and Registrar shall be an ex officio member of the Academic Council of the University and shall, in the absence of the President, be entitled to preside at meetings of the Academic Council.

CHAPTER II

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall come into operation on the Twenty-Sixth day of April, Two Thousand and Twenty Three and may be cited as Statute CCCLXXIX, National University of Ireland, Galway or Stat. CCCLXXIX, Nat. Univ. of I., Galway.

CAIBIDIL I

AN tUACHTARÁN IONAIÐ AGUS MEABHRÁNAÍ

1. Is é an tUachtarán Ionaid agus Meabhránaí, ag gníomhú dó nó di faoi threoir ghinearálta an Uachtaráin, a bheidh ina P(h)ríomh-Oifigeach Acadúil; agus beidh sé nó sí freagrach as ceannaireacht agus straitéis acadúil na hOllscoile a threorú; agus déanfaidh sé nó sí gach gníomh eile den sórt sin agus comhlíonfaidh sé nó sí gach dualgas eile den sórt sin maidir le gnó acadúil na hOllscoile de réir mar a iarrfaidh an tUachtarán agus Údarás na hOllscoile air nó uirthi a dhéanamh nó a chomhlíonadh.
2. Beidh an tUachtarán Ionaid agus Meabhránaí céim amháin faoi bhun an Uachtaráin. Cabhróidh an tUachtarán Ionaid agus Meabhránaí leis an Uachtarán agus gníomhóidh sé nó sí mar ionadaí don Uachtarán ar cibé modh a ordóidh an tUachtarán.
3. Post lánaimseartha a bheidh i gceist le post an Uachtaráin Ionaid agus Meabhránaí agus beidh sé nó sí ina bhall nó ina ball d'Fhoireann Bainistíochta na hOllscoile.
4. Déanfaidh Údarás na hOllscoile an tUachtarán Ionaid agus Meabhránaí a cheapadh de réir thuairisc an Bhoird Measúnóirí arna cheapadh ag Údarás na hOllscoile chun na críche sin, tar éis don Chomhairle Acadúil moltaí a dhéanamh maidir lena bhallraíocht. Tabharfaidh an Bord Measúnóirí faoi cibé agallaimh agus nósanna imeachta eile a chinnefidh Údarás na hOllscoile, tar éis dó moltaí a fháil ón gComhairle Acadúil maidir le riachtanais an róil, agus arb iad is fearr, i dtuairim Údarás na hOllscoile, a chinnteoidh go mbeidh iarrthóirí ar ardchaighdeán laistigh den Ollscoil agus lasmuigh di páirteach sa phróiseas roghnúcháin.
5. Beidh an tUachtarán Ionaid agus Meabhránaí i seilbh na hoifige sin, faoi réir dea-iompair, tréimhse phromhaidh bliana shásúil a bheith caite aige nó aici, agus dualgais an phoist a bheith comhlíonta go cuí i rith na tréimhse oifige, ar feadh tréimhse suas le cúig bliana nó go dtí go mbeidh an aois scoir dhlíthiúil don earnáil phoiblí bainte amach aige nó aici, cibé tréimhse díobh a rachaidh in éag i dtosach, agus gach ceann díobh faoi réir na dtéarmaí atá leagtha amach sa chonradh fostaíochta agus sa tsonraíocht phoist.
6. Beidh an tUachtarán Ionaid agus Meabhránaí ina bhall nó ina ball ex officio de Chomhairle Acadúil na hOllscoile agus beidh sé nó sí i dteideal, in éagmais an Uachtaráin, a bheith i gceannas ar chruinnithe den Chomhairle Acadúil.
