**REGULATION 2/2010**

WE, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Regulation contained in the Schedule hereto for the general government of the said University.

**Schedule - REGULATION 2/2010**

All previous Regulations of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

## **CHAPTER I**

### **THE VICE-PRESIDENT FOR INNOVATION AND PERFORMANCE**

1. The Vice-President for Innovation and Performance, under the direction of the President and in accordance with policy determined by Údarás na hOllscoile, shall have responsibility for the promotion of innovation in all aspects of the operation of the University and for the development and implementation of strategies to ensure the sustained enhancement of performance in all areas of the University.
2. The Vice-President for Innovation and Performance shall be a member of the University Management Team and shall attend, as required, at meetings of Údarás na hOllscoile and any relevant committees thereof.
3. The Vice-President for Innovation and Performance shall consult, as directed by the President, with other officers of the University in respect of matters of common concern.

## **CHAPTER II**

### **THE VICE-PRESIDENT FOR PHYSICAL RESOURCES**

1. The office of the Vice-President for Physical Resources, as set out in Regulation 2/2003, is hereby retitled the office of the Vice-President for Capital Projects.
2. Regulation 2/2003 is hereby amended by the substitution of the following Section for Sections 1 and 2 of Chapter 1 therein and by the renumbering of Sections 3 and 4 as Sections 2 and 3, respectively:  
  
“1. The Vice-President for Capital Projects, under the direction of the President and in accordance with policy determined by Údarás na hOllscoile, shall have responsibility for all matters relating to the planning and delivery of the capital building programme of the University.”

## **CHAPTER III**

### **THE VICE-PRESIDENT FOR STUDENT SERVICES AND HUMAN RESOURCES**

1. The office of the Vice-President for Student Services and Human Resources, as set out in Regulation 2/2003, is hereby retitled the office of the Vice-President for the Student Experience.
2. Regulation 2/2003 is hereby amended by the substitution of the following Sections for Sections 1-5 of Chapter 1 therein:

- “1 The Vice-President for the Student Experience, under the direction of the President, but reporting to the Registrar and Deputy-President, and in accordance with policy determined by Údarás na hOllscoile, shall have responsibility for:
- (a) enhancing the quality of the experience, from admission to graduation, of all students of the University.
  - (b) the provision of comprehensive support for students to ensure maximum engagement with the academic life of the University.
  - (c) the extracurricular activities of students and securing access to facilities to enable such activities.
  - (d) the development, implementation and monitoring of strategies directed towards the personal development of students.
2. The Vice-President for the Student Experience shall consult, as directed by the President, with other officers of the University, and in particular with the Registrar and Deputy-President, and with others as appropriate in respect of matters of common concern.
3. The Vice-President for the Student Experience shall attend, as required, at meetings of Údarás na hOllscoile and any relevant committees thereof.”

## **CHAPTER IV**

### **THE VICE-PRESIDENT FOR RESEARCH**

1. Regulation 1/2004 is hereby amended as follows:
- (a) in Section 1 by substitution of the words “under the direction of the President, but reporting to the Registrar and Deputy-President” for “under the direction of the President” therein.
  - (b) in Section 2(c) by the deletion of the words “in consultation with the Vice-President for Strategic Initiatives and External Affairs” therein.
  - (c) by the substitution of the following Section for Section 3 of Chapter 1 therein:

“3. The Vice-President for Research shall attend, as required, at meetings of Údarás na hOllscoile and any relevant committees thereof”.

## CHAPTER V

### THE VICE-PRESIDENT FOR STRATEGIC INITIATIVES AND EXTERNAL AFFAIRS

1. Regulation 1/2003 is hereby revoked.

## CHAPTER VI

1. This Regulation shall come into operation on the thirtieth Day of April, Two Thousand and Ten, and may be cited as Regulation 2/2010, National University of Ireland, Galway, or Reg. 2/2010, Nat. Univ. of I., Galway.

## **CAIBIDIL I**

### **AN LEAS-UACHTARÁN UM NUÁLAÍOCHT AGUS FEIDHMÍOCHT**

1. Beidh an Leas-Uachtarán um Nuálaíocht agus Feidhmíocht, faoi stiúru an Uachtaráin agus de réir an pholasaí a chinnfear ag Údarás na hOllscoile, freagrach as Nuálaíocht a chur chun cinn sna gnéithe uile d'oibriú na hOllscoile agus as straitéisí a fhorbairt agus a chur i bhfeidhm a chinnteoidh go mbeidh feabhsú leanúnach ar fheidhmíocht i réimsí uile na hOllscoile.
2. Beidh an Leas-Uachtarán um Nuálaíocht agus Feidhmíocht ina c(h)omhalta d'Fhoireann Bhainistíochta na hOllscoile agus beidh sé/sí i láthair, de réir mar is gá, ag cruinnithe d'Údarás na hOllscoile agus d'aon Choiste de sin a bhaineann le hábhar.
3. Rachaidh an Leas-Uachtarán um Nuálaíocht agus Feidhmíocht i gcomhairle, de réir mar a ordóidh an tUachtarán, le hoifigigh eile den Ollscoil ar na nithe sin is cuid spéise i bpáirt acu.

## **CAIBIDIL II**

### **AN LEAS-UACHTARÁN UM ACMHAINNÍ FISIÚLA**

1. Gairfear leis seo oifig an Leas-Uachtaráin um Thionscadail Chaipitil d'oifig an Leas-Uachtaráin um Acmhainní Fisiciúla, mar a leagadh amach í i Rialachán 2/2003.
2. Déantar Rialachán 2/2003 a leasú leis seo tríd an Alt seo a leanas a chur in áit Ailt 1 agus 2 de Chaibidil I ansin agus trí Ailt 2 agus 3, faoi seach, a dhéanamh d'Ailt 3 agus 4:  
  
“1. Beidh an Leas-Uachtarán um Thionscadail Chaipitil, faoi stiúru an Uachtaráin agus de réir an pholasaí a chinnfear ag Údarás na hOllscoile, freagrach as na nithe uile a bhaineann le pleanáil agus seachadadh chlár tógála caipitil na hOllscoile.”

## **CAIBIDIL III**

### **AN LEAS-UACHTARÁN UM SHEIRBHÍSÍ MAC LÉINN AGUS ACMHAINNÍ DAONNA**

1. Gairfear leis seo oifig an Leas-Uachtaráin um Eispéireas na Mac Léinn d'oifig an Leas-Uachtaráin um Sheirbhísí Mac Léinn agus Acmhainní Daonna, mar a leagadh amach í i Rialachán 2/2003.
2. Déantar Rialachán 2/2003 a leasú leis seo trí na hAilt seo a leanas a chur in áit Ailt 1-5 de Chaibidil I ansin:

- “1 Beidh an Leas-Uachtarán um Eispéireas na Mac Léinn, faoi stiúru an Uachtaráin, ach ag tuairisciú don Mheabhránaí agus Uachtarán Ionaid, agus de réir an pholasáí a chinnfear ag Údarás na hOllscoile, freagrach as:
- (a) caighdeán eispéireas mac léinn uile na hOllscoile, ó iontráil dóibh go bronnadh na céime orthu, a fheabhsú.
  - (b) tacaíocht chuimsitheach a chur ar fáil do mhic léinn lena chinntiú go mbeidh siad dírithe oiread agus is féidir ar shaol acadúil na hOllscoile.
  - (c) gníomhaíochtaí na mac léinn lasmuigh den churaclam agus a chinntiú go mbeidh teacht acu ar áiseanna a ligfidh dóibh gabháil do na gníomhaíochtaí sin.
  - (d) straitéisí a bheidh dírithe ar fhorbairt phearsanta na mac léinn a fhorbairt agus a fheidhmiú agus monatóireacht a dhéanamh orthu.
2. Rachaidh an Leas-Uachtarán um Eispéireas na Mac Léinn i gcomhairle, de réir mar a ordóidh an tUachtarán, le hoifigigh eile den Ollscoil, agus go háirithe leis an Meabhránaí agus Uachtarán Ionaid, ar na nithe sin is cuid spéise i bpáirt acu.
3. Beidh an Leas-Uachtarán um Eispéireas na Mac Léinn i láthair, de réir mar is gá ag cruinnithe d’Údarás na hOllscoile agus d’aon Choiste de sin a bhaineann le hábhar.”

## CAIBIDIL IV

### AN LEAS-UACHTARÁN UM THAIGHDE

1. Déantar Rialachán 1/2004 a leasú leis seo mar leanas:
- (a) in Alt 1 trí na focail “faoi stiúru an Uachtaráin, ach ag tuairisciú don Mheabhránaí agus Uachtarán Ionaid” a chur in áit “faoi stiúru an Uachtaráin” ansin.
  - (b) in Alt 2(c) trí na focail “i gcomhairle leis an Leas-Uachtarán um Thionscnaimh Straitéiseacha agus Ghnóthaí Eachtracha” a scriosadh ansin.
  - (c) tríd an Alt seo a leanas a chur in áit Alt 3 de Chaibidil I ansin:

“3. Beidh an Leas-Uachtarán um Thaighde i láthair, de réir mar is gá, ag cruinnithe d’Údarás na hOllscoile agus d’aon Choiste de sin a bhaineann le hábhar”.
